The appellant stated that no information has been provided to him by the SPIO.

The appellant filed RTI application on 21.01.2021 and a period of about 7 months has been passed, but the SPIO has not provided the sought for information to the appellant. The appellant is suffering from the hands of the SPIO. So, a compensation of Rs. 2,000/- is awarded in favour of the appellant to be paid by the SPIO from the funds of the public authority by way of demand draft and be sent to the appellant through registered post within 15 days along with attested copies of information. In case of non compliance of the Order of the Commission, a Show Cause Notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO on the next date of hearing and he may be penalized upto Rs.25,000/-.
