He states that since his case regarding claim of damages is still pending in the court, he needs to be apprised of the decision of the competent authority as also the detail regarding putting up his case on file, in view of his submission given to PSPCL for out of court settlement.

5. The Bench, on perusal of the letter dated 22.07.2022 produced before the Bench as well as the documents i.e. office noting etc. attached therewith, observes that the case of the appellant regarding out of court settlement was put up to the CMD, PSPCL who, in view of the legal opinion as contained in the said noting sheet, has approved to file SLP in the Hon'ble Supreme Court of India. The appellant is clarified this fact and that the information as available in the official records has been supplied to him.

6. However, instead of informing her as to whether he is satisfied with the information, he questions the authority for her appearance on behalf of the PIO before the Commission and states that due to ill health, he is in the hospital, however, states that information has not been received by him.

4. The Bench, after hearing the statement of the representative of PIO and going through the contents of letter dated 08.08.2022, is convinced that point-wise information stands supplied to the appellant. However, the appellant, as informed on phone, has not received the information yet. On the asking of the Bench, the representative of PIO states that apart from the information supplied, no other information relating to RTI application is available in the official records.

5. The Bench now, directs the PIO to file an affidavit on non judicial stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.4994/2021, has been supplied to the appellant. It be further stated that nothing has been concealed therein and the information supplied is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

6. In view of the above, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties. Copy of the letter dated 08.08.2022 is sent to the appellant along with the order.

It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.

6. With the aforesaid directions, **the instant appeal case is disposed off and closed.**
