4. Both the parties agree for inspection of work site to draw a sample on 01.10.2020. The appellant is directed to visit the office of the Respondents for drawing sample on 01.10.2020 from 11.00AM to 12.00PM. He is further directed to be present on the next date of hearing to pursue his case.

5. The representative of the Respondents is directed to be present at the time of sample drawing on 01.10.2020 from 11.00AM to 12.00PM failing which penal proceedings shall follow. He is further directed to be present personally on the next date of hearing to represent the case.
