Commission dated 19.8.2021 and a copy of the resolution passed and vetting report regarding the Point No. 3(4). However the representative of the respondents handed over a copy of the resolution and the vetting report pertaining to point No. 3(2). He further clarified that no separate vetting report is available on record and register of tenders work may be treated as vetting report. With regard to Point No.3(4) the appellant states that the copy supplied by the respondent is not readable, however, the representative of the respondent states that the copy of the resolution in a readable/legible copy of the same will be supplied to the appellant. Regarding copy of the register of tender work has been placed on record by the representative of the respondents and a copy of the same has been handed over to the appellant during the course of hearing. Accordingly the directions are issued to the respondent Public information Officer to supply the remaining information i.e. a legible copy of the resolution passed and vetting report of the estimate pertaining to Point No. 3(4) and the representative of the respondents assured that the same will be supplied to the appellant within a week.
