The PIO, Sh. The issue is taken up today. Shri Harmesh Kumar O/o Tehsildar, Kharar has brought along a copy of the mutation No.26370 which has been sanctioned on the basis of registered sale deed. Certified copy has been handed over to the complainant on spot. The Commission takes a strong view of the fact that despite show cause notice having been issued to the Tehsildar, he has not bothered to take due cognizance of the orders of Commission. Copy of the compromise deed on the basis of which mutation No.9889 was sanctioned has still not been provided to the complainant. He is directed to do the same without further delay. Meanwhile, he shall submit his explanation in writing on the show cause notice already issued to him. The case has come up today. Sh. Mandeep Singh, Tehsildar, Kharar, himself is present. He has filed an affidavit in which he has stated that the available documents have been provided to the information seeker. He further submits that the agreement in contention was unregistered and they have not been able to trace it from their office record despite their best efforts. The Commission is inclined to accept his submissions and does not find any malafide intent on the part of the respondents. The available information has been provided. No further action seems to be called for.
