1. The RTI application is dated **25.9.2020** vide which the appellant has sought information **regarding a complaint bearing Diary No. 2108-PS-R dated 21.9.2020**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **30.10.2020** and Second Appeal was filed in the Commission on **18.12.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.9.2021**.
