4. The PIO is directed to supply remaining information to the appellant and in case no more information is available then she should file a proper affidavit duly notarised. She is further directed to send the original affidavit to the appellant by registered post and copy of the same be sent to the Commission before the next date of hearing.
5. The case is adjourned for further hearing through **CISCO WEBEX** meeting **ID No.159 864 6555** on **02-12-2021 at 11.00 AM**. Both the parties are directed to be present on the next date of hearing. Copies of order may be sent to the parties.
