I have gone through the Order dated 13.10.2021 and I impose a penalty of Rs.10,000/- upon Mr. Balwinder Singh, PIO-cum-Panchayat Secretary, Gram Panchayat Valoor and also impose a penalty of Rs.10,000/- upon Mr. Charanjit Singh, PIO-cum-APO, MANREGA, Block Ghal Khurd. The Drawing & Disbursement Officer of the O/o BDPO, Ferozepur was directed that the amount of penalty of Rs.10,000/- each be deducted from the salary of concerned persons and compliance be sent to the Commission.

The Commission has received a mail sent by the BDPO, Ferozepur on 15.11.2021, diarized vide no.25708, which is a copy of letter no.2570 dated 11.11.2021. I have gone through the said letter and the BDPO, Ferozepur stated that Mr. Balwinder Singh, PIOcum-Panchayat Secretary, Gram Panchayat Valoor and Mr. Charanjit Singh, PIO-cum-APO, MANREGA, Block Ghal Khurd are posted in Block Ghal Khurd. It is further submitted that the deduction of amount of penalty from the salary of Mr. Balwinder Singh PIO-cum-Panchayat Secretary is to be done by the BDPO, Ghal Khurd and the deduction of amount of penalty from the salary of Mr. Charanjit Singh, PIO-cum-APO, MANREGA, Block Ghal Khurd is to be done by the office of the Additional Deputy Commissioner (Dev.), Ferozepur.


