## ORDER

He adds that he has sent his representation dated 15.11.2022 for the same via email dated 17.11.2022, which is received and taken on record.

After hearing both the parties in detail and examining the documents placed on record, appellant failed to send letter regarding specific information within given time, as he was advised on hearing held on 07.09.2022 after the ample time has elapsed, which means he is not serious towards the orders of the Commission.
