ORDER

1. This order may be read with reference to the previous order dated 22.10.2018.
2. Respondent, Sh. Apar Apaar Singh states that pending information relates with point no. 3 has already been supplied to the appellant. He submits a copy of letter no. 127 dated 12.11.2018 along with another document signed by the rent clerk, Komal Sharma, Nagar Council, Jaiton, dated 11.10.2018, which are taken on record.
3. Respondent, Ms. Poonam Bhatnagar states that this case was disposed of and closed and requested to exempt her from the further hearings. She also mentioned that after four years she received order of this case as now she is not posted as PIO, NC, Jaiton
4. After hearing both the parties and examining the case file, it is found that this case was sine-die by the Bench of the then Ld. SIC, Sh. Chander Parkash vide order dated 11.01.2016 as Matter was pending before the Hon'ble Punjab and Haryana High Court.

This case was remitted to the Commission to decision afresh vide order dated 12.10.2017 of the Punjab and Haryana High Court, passed by the Hon'ble Justice Sh. Rajan Gupta in CWP 26273 of 2015. Accordingly, the case was fixed for hearing on 19.02.2018.

5. On hearing held on **19.02.2018**, both the parties were absent and matter was adjourned for further hearing on 02.04.2018 to represent this case. Hearing which was earlier fixed for 02.04.2018 was postponed and fixed for 17.04.2018

6. On hearing held on **17.04.2018**, representative of the appellant, Sh. Madan Lal was appeared and stated that information relates with pont no. 3, 4 and 16 is still pending but currently only point no. 3 of the RTI application is required. Respondent PIO was absent without any intimation to the Commission. Respondent PIO was directed to provide the requisite information that relates with point no. 3 and matter was adjourned for further hearing on 21.05.2018.

7. On hearing held on **21.05.2018**, respondent PIO was continuously absent third time without any information to the Commission and Show Cause notice was issued to him along with directions to supply the pending information that relates with point no. 3 of the RTI application. Matter was adjourned for further hearing on 20.06.2018.

8. On hearing held on **20.06.2018**, respondent PIO was absent without intimation to the Commission. It was also observed that respondent PIO not filed any reply to the Show Cause notice issued to him vide order dated 21.05.2018. One more opportunity was given to the respondent PIO to file reply to the Show Cause notice issued to him long with directions to supply the information relates with point no. 3. Copies of this order were sent to the respondent PIO and FAA through registered post and matter was adjourned for further hearing on 23.07.2018. Hearing which was earlier fixed for 23.07.2018 was postponed and fixed for 26.07.2018

9. On hearing held on **26.07.2018**, representative of the appellant, Sh. Madan Lal stated information relates with point no. 3 is still pending from the respondent PIO was absent continuously fifth time without intimation to the Commission. Compensation amounting Rs. 3,000/- was awarded to the appellant. Another opportunity was given to the respondent PIO to appear in person along with directions to supply the pending information that relates with point no. 3. Copies of this order were sent to the respondent PIO and FAA through registered post and matter was adjourned for further hearing on 23.07.2018. Hearing which was earlier fixed for 22.08.2018 was postponed and fixed for 25.09.2018.

10. On the hearing held on **25.09.2018** and stated that information relates with point no. 3 is still pending. He also requested for compensation be awarded to the appellant and to restore the penalty imposed by the then Ld. SIC, Sh. Chander Parkash be restored as the appellant has suffered a lot of detriments for not getting information on time. Various observations were taken on record as mentioned in the order of the Commission dated 25.09.2018. Last opportunity was given to the EO cum instant respondent PIO, Sh. Narinder Kumar to supply to comply with the order of the Commission dated 26.07.2018. A copy of this order was sent through registered post to Ms. Poonam Bhatnagar by name. Copies of this order was also sent to the Chief Secretary and to the Principal Secretary through registered post for necessary action as deemed it fit Matter was adjourned for further hearing on 23.07.2018. Hearing which was earlier fixed for 22.10.2018.

11. On the hearing held on **22.10.2018**. Sh. Narinder Kumar appeared on behalf of the respondent submits a letter no. 127-128 dated 12.10.2018 along with supporting documents regarding the compensation acknowledgement signed by the appellant, Sh. Harish Chader with remarks cheque amounting Rs. 3,000 and information has been received, which were taken on record.

It was observed that matter was remitted to the Commission for decision afresh vide order dated 12.10.2017 of Punjab and Haryana High Court passed by Hon'ble Justice Mr. Rajan Gupta in CWP 26273 of 2015.

Respondent, Ms. Poonam Bhatnagar was directed to appear in person along with reply on the next date of hearing. A copy of order dated 22.10.2018 was sent to Ms. Poonam Bhatnagar through registered post and matter was adjourned for further hearing held on 21.11.2018.

Hearing which was fixed for 21.11.2018 has been postponed and matter is fixed for further hearing on 17.12.2018 i.e. today.

12. After hearing both the respondents and examining the case file, respondent PIO, Sh. Apar Apaar Singh is directed to file an affidavit in connection with point no. 3 of the RTI application on the next date of hearing.

Respondent, Ms. Poonam Bhatnagar is directed to file a proper reply on the next date of hearing to clear the facts positively. A copy of this order be sent to her through **registered post** along with copies of orders dated 25.09.2018 and 22.10.2018 for her ready reference.

13. A copy of this order be sent to the Chief Secretary to Govt. of Punjab, Punjab Civil Secretariat, Sector-1, Chandigarh and to the Principal Secretary to Govt. of Punjab, Department of Local Govt Punjab Civil Secretariat, Sector 9, Chandigarh to look into the matter.

14. Matter is adjourned for further hearing on **23.01.2019 at 11:30 A.M.**
