3. Section 10 of the RTI Act, 2005 provides that

"10. (1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information. "

4. It is also pertinent to mention here the decision of the Hon'ble High Court of Delhi in Dr. R.S. Gupta Vs Govt. of Netd and others in which the appellant has sought the information pertaining to the attendance register pertaining to him and also of the rest of the staff members serving in the same school. The relevant portion of the judgement is reproduced below:-

".....11....Let the information pertaining to appellant's personal attendance record, that was provided earlier, be furnished to him once again, within 3 weeks from today. The appeal is dismissed with the above directions."

5. After detailed deliberations with both the parties and keeping in view the above, the directions are issued to the respondent-Public Information Officer to provide the copy of attendance register related to the appellant from September 2016 to 31st July, 2021 as has been sought by him as per Section 10 of the RTI Act, 2005 as enumerated above i.e. information pertaining to Point No. 1 of the RTI application. Regarding Point No. 3 of the RTI application of the appellant, the
