ORDER:

1. The RTI application is dated **16.6.2020** vide which the appellant has sought information **regarding his application dated 6.6.2020 to DC SAS Nagar**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **20.7.2020** and second appeal was filed in the Commission on **4.9.2020** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **17.3.2021**.

2. The appellant is absent but has informed the Commission that he has received the requested information. The respondent PIO, represented by Harjeet Kaur, Senior Assistant, present via Video Conference from the Deputy Commissioner's Office at Mohali, stated that the requested information was sent to the appellant, within the stipulated 30-day period, vide Letter No. 4604/RTI dated 9.7.2020. ORDER:

1. The RTI application is dated **25.7.2020** vide which the appellant has sought information **regarding his applications of 23.1.20 and 1.2.20 about the conversion of residential area into commercial area**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **18.10.2020** and second appeal was filed in the Commission on **28.12.2020** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **17.3.2021**.

2. The respondent PIO is absent without intimation. The appellant, Sundeep Goyal, acknowledged that the respondent PIO has sent him a written, point-wise reply vide Letter No. 492/BCD dated 27.10.2020. The appellant contended that the said reply is "incomplete and does not address all the points of the RTI application". An examination of the PIO's reply, however, revealed that most of the unanswered points are in the form of questions not admissible as per the RTI Act, 2005.

3. This Commission is of the view that the respondent PIO's reply adequately addresses this RTI application.

4. There is no further cause for action and this appeal case is herewith **CLOSED**.
