ORDER

The RTI Application is dated 05.04.2021 vide which the appellant has sought information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 06.05.2021 and Second Appeal was filed in the Commission on 09.03.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 17.05.2022.

2. The appellant submits that the correction was made vide Farad Badar No. 28 dated 3.10.2014 in the name of Sh. Harjit s/o Sh. Tarsem Singh s/o Sh. Puran Singh having 1/5 share but the said correction was not entered in the Jamabandi of 2019-20. He further submits that since then he is repeatedly requesting the department to update the same but till date no action has been taken by the revenue officials to correct the new 'JamaBandi' prepared in 2019-2020. However, the representative of the respondent submits that the appellant has sought the information in the question form and requested to close the case, as per the provisions of the Right to Information Act, 2005.

3. After detailed deliberations with both the parties regarding the sought information the respondent Public Information Officer is directed to provide the status of the applications filed by the appellant on 16 September 2019, 30 September 2019 and 10 December 2020 before the next date of hearing.
