- 3. This Commission does not concur with the contention of the complainant and nor does it view that such disclosure would serve any larger public interest. The Commission sees no further cause for action and this complaint case is herewith, **CLOSED**.

Nonetheless, acting on the speaking order at the hearing on 17.6.20, the respondent PIO has supplied the information requested at point 4 of the RTI application. This was sent to the complainant vide registered post as enumerated in the Order of 21.8.20. The complainant had meanwhile (in a letter dated 22.6.20) contended that the information sought by him at points 3 and 6 of his RTI application is not third party information and must therefore be disclosed to him.
- 3. This Commission does not concur with the contention of the complainant and nor does it view that such disclosure would serve any larger public interest. The Commission sees no further cause for action and this complaint case is herewith, **CLOSED**.
