Appeal Case No. 1324 of 2021

Decision:

7. The Commission, after hearing the submissions of both the parties and after perusal of records observes that the respondent has given point-wise reply/information to the appellant on his RTI application dated 04.07.2018. The Commission further observed that the respondent has wrongly denied the information under Section 8(1)(j) of the RTI Act on point no. 1 of the RTI application. The name, designation, official address of any employee cannot be treated as personal information of third party. However, information regarding copy of aadhar card, etc. is personal information of third party which is exempted from disclosure under Section 8(1)(j) of the RTI Act. In view of this, the Commission directs the respondent to give revised reply/information to the appellant on point no. 1 of the RTI application informing him the name, designation and official address of the employee, within a period of 15 working days from the date of receipt of this order.

8. With the above observations, the appeal is disposed of.

Also the Commission relies on the decision dated 13.11.2019 of Hon'ble Supreme Court of India in Civil Appeal no. 10044 of 2010 titled Supreme Court of India vs Subhash Chander Aggarwal. The relevant part of the decision is reproduced:

"Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive"

5. That Aadhar card also contains personal information i.e. name, address etc.

6. That in view of the above, no more action is required to be taken in this case. Hence this case is disposed of and closed.
