1. The RTI application is dated **30.1.19** vide which the appellant has sought <u>information</u> <u>pertaining to three applications – No. 3205-PP/DPO Tarn Taran; No. 5381-COP dated</u> <u>8.11.17; and 4730/DGP dated 27.11.18</u> etc., as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) and second appeal was filed in the Commission on **19.11.19** under Section 19 of the Right to Information Act, 2005. The case was last heard on **5.2.2020**.

2. The appellant is absent without intimation for the second time. The respondent PIO, represented by ASI Hira Singh, had informed the Commission at the last hearing that an FIR was registered in the case cited in the RTI application. Copy of the FIR was sent to the Commission and has now also been sent to the appellant.
