Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 10.09.2019. The complaint has been received in the Commission on 27.12.2019.

On the last date of hearing, held on 26.11.2020, Sh. Raghubir Singh, Sanitary Inspector and Sh. Rajesh Rehmi, Junior Engineer, stated that the requisite information (of thirty six pages), was sent to the complainant vide letter dated 23.11.2020 with a copy to the Commission. The complainant stated that he had not received the above-mentioned information. The representatives of the respondent PIO stated that as the information was sent to the complainant vide letter dated 23.11.2020, which would be delivered by the Postal Authorities to the complainant within coming two or three days from that day. An opportunity was also given to the respondent PIO to send a copy of the supplied information (which was sent to the complainant) to the Commission. An opportunity was also given to the appellant to confirm whether he has received the information, to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned.

The complainant, Sh. P. D. Bansal , is not present in today's hearing.

Sh. Charanjit Singh, Executive Officer, who appeared in person in today's hearing, states that the requisite information has already been supplied to the complainant vide letter no. 2249-50 dated 23.11.2020 through registered post.

He also intimates the Commission that a reply has also been sent to the Commission vide letter no. 2250 dated 23.11.2020, which has been received in the Commission through an e-mail, showing that the requisite information has already been supplied to the complainant. It, alongwith a copy of postal receipt, is taken on record.

Since complete information has been supplied by the respondent PIO to the complainant and the complainant has also not approached the Commission with any contrary claim. It is assumed that the complainant is satisfied with the information supplied to him.

In view of all the above, the case is announced as disposed of and closed.
