2. The complainant states that the respondents are providing the incomplete information as the information related to the year 2004 to 2013 has not been provided. However, the Panchayat Secretary states that he has brought the information comprising of around 1800 pages and he handed over the same to the appellant during the course of hearing. The Panchayat Secretary further states that he is unable to supply the information related to the year 2004 to 2013 as no record pertaining to this period is in his custody. In addition he states that the appellant may be directed to deposit the fee which will become thousands of rupees. After hearing the submission made by the representative of the respondents, the appellant requests for the information after identification of the record.

3. Accordingly, Sh.
