The appellant through RTI application dated 25.05.2019 has sought information 12 points regarding action taken on letters sent from 01.04.2019 till date for not reinstating Davinder Kumar Clerk – copy of charge sheet – service books of Ramesh Kumar, Suresh Kumar, Davinder Kumar who were arrested under section 326 CPC - correspondence done by Police station Jaito in case of Ramesh Kumar and Suresh Kumar and action taken on those letters from the year 2011 – copy of letters submitted for extension by employees Darsh Singh, Raj Singh, Prem Kumar, Peetambar Kumar, Balwinder Singh, Manak Chand etc. and other information as enumerated in the RTI application concerning the office of EO, MC Jaito. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 16.12.2019 which took no decision on the appeal.

The case was first heard on 26.08.2020. The respondent present pleaded that the available information has been provided to the appellant. The appellant was not satisfied and informed that the information has not been provided as per the RTI application.

As per respondent, the RTI application was not specified. Having gone through the RTI application, the Commission observed that the RTI application is not legible.

The appellant was directed to send a legible typed application to the PIO with a copy to the Commission. The PIO was directed to relook at the RTI application and provide the information to the appellant as per record.

Hearing dated 18.01.2021:

The case has come up for hearing today through video conferencing at DAC Faridkot. The appellant is absent and vide email has sought exemption.

The respondent present has pleaded that the information (168 pages) is ready but the appellant has not come to collect the information since he had desired to collect the same by hand.

ORDER:

The appellant through RTI application dated 02.12.2019 has sought information regarding copy of receipt books – copy of bills relating to payment of Jain Brothers – payment received from VATS and finance commission – notification relating to exemption on penalty & interest – suspension order of Davinder Kumar earnest money of tree auction – notice u/s 195-A on Balwinder Singh -proceedings done against Ramesh Kumar, Prem Chand and Davinder Kumar and other information concerning the office of EO, MC Jaito. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 02.12.2019 which took no decision on the appeal.

The case was first heard on 26.08.2020. The respondent present pleaded that the appellant was asked vide letter dated 10.12.2019 to deposit requisite fee and get the information. The appellant informed that no such letter was received.

Having gone through the record and hearing both the parties, the Commission found that since the respondent was not able to prove the dispatch of letter dated 10.12.2019 and also the First Appellate Authority had taken no decision on the appeal, the PIO was directed to provide the information to the appellant free of cost.

ORDER:

The appellant through RTI application dated 18.01.2020 has sought information regarding list of employees posted in NC Jaito along with contractual employees and salary paid in Jan.2020 – complete detail relating to death of sweeper Pappal on 29.12.2007 – applications received for appointment after death of that employee – applications of Rahul claiming the son of Pappal and other information concerning the office of NC Jaito. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 15.03.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Faridkot. The respondent present pleaded that since the appellant had not attached the ID proof with the RTI application, the appellant was asked to submit ID proof vide letter dated 22.06.2020 but the appellant has not submitted the ID Proof.
