**Provide the certified copy of complete noting portion relating to my (Sh. Dheeraj Khullar) transfer from H.O to MVAI, Khanna. The transfer order in this regard were issued under Endst. No. EST/EAG-1/2020/2296 dated 02.07.2020 on administrative grounds.**

2. Appellant Sh. Dheeraj Khullar sates that the partial information has been provided by the respondent PIO (pertaining to point no. 1 of the RTI application). He further added that “the actual major copy of relevant noting portion relating to my transfer, where the competent authority/M.D. had passed order to transfer me and that too out of head office, was not been made part of the information”.
3. On this, respondent Ms. Baldev Krishnan contended that the complete information (comprising 04 pages) has been supplied to the appellant pertaining to the points enumerated in the RTI application filed. She further added that no any other information related to this is available in the office record.
4. After hearing both the parties and going through the information supplied by the respondent PIO, the Commission finds that the RTI application has been **suitably replied** and the information has been supplied to the **best extent**.

Therefore, no cause of action is required in this case. Hence, the instant appeal case is **disposed & closed**.
