



- 5. The Bench, on listening to the version of the appellant and perusing the case file, observes from the statement of the representative of the PIO that the PIO is misleading the Bench, as reply to the show cause notice as well as the affidavit has purportedly been sent vide letter dated 30.10.2020, whereas on the previous date of hearing, i.e. 04.11.2020, no such letter was available in the case file and the Bench had directed to file reply to the show cause notice. The Bench further observes that the penalty imposed on the previous hearing has also not been deposited and, thus, order of the Bench has not been complied with.
- 6. In view of the fact that the PIO has mislead the Bench and has also not complied with the directions of the Bench in its entirety, the affidavit filed by the PIO is not accepted.
- 7. The PIO is directed to supply complete information to the appellant, as identified by him, before the next date of hearing as also to come in person to attend the hearing before the Bench at Chandigarh. He is also directed to produce evidence for having deposited the penalty on the next date as also to file an affidavit, as per directions given on the previous date of hearing.




