ORDER

(Heard in person/Through Cisco Webex)

1. The RTI application is dated 21.10.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.05.2021 and the second appeal was filed in the Commission on 28.09.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 18.01.2022 in Commission's office at Chandigarh. Shri Pargan Ram, appellant comes present to attend the hearing through cisco webex along with Mrs. Laxmi, Advocate. He states that he has sought information with regard to a decision taken to give Panchayat land to one Kuldip Kumar who was his uncle as also copies of his statement recorded in connection with letter No.1177 dated 11.08.2020 and reference No.1203 dated 17.08.2020. However, no information has been supplied.

3. Shri Jeevan Lal, Superintendent O/o BDPO Aur, District Nawanshahar comes present to attend the hearing in person before the Bench on behalf of the PIO. He states that as per report of Panchayat Secretary, Gram Panchayat, Mukandpur, a resolution was passed by Gram Panchayat, Mukandpur 22.02.1976 for giving Panchayat land on lease which was given to one Kuldip Kumar. However, there is no such document available on the basis of which the said land was transferred to the said Kuldip Kumar and that copy of resolution has been supplied to the appellant on 05.11.2020.

4. The appellant makes the Bench to talk to his counsel Mrs. Laxmi Bansal, who states that on the land in question, three shops were constructed and the son of said Shri Kuldip Kumar has sold one of the shops and there must be some document on the basis of which the property has been sold.

5. On the asking of the Bench, the representative of PIO states that the information asked for relates to the record for the year 1976 and except the copy of resolution passed by the Gram Panchayat, Mukandpur, no other document is available in the records of Gram Panchayat.

6. Post deliberations, the Bench directs the PIO to file an affidavit on non-judicial stamp paper within twenty one days duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.4371 of 2021 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and photocopy of the same be sent to the Commission for record.

7. With the aforesaid directions, **the appeal case is disposed off and closed.** Copies of the orders be sent to the concerned parties.
