ORDER:

This order may be read with reference to the previous order dated 28.01.2020.

2. The appellant is present today. He states that the information supplied is incomplete and the same is unattested. He further reiterates his earlier submission that the BDPO Fazilka has not made the payment of compensation amount of Rs.4000/- till date.

3. Today i.e. on 18.02.2020, the appellant is present whereas Shri Parvesh Singh, BDPO-cum-PIO, is absent. He was also absent on 28.01.2020. Thus judging the defying attitude of the Respondent-PIO, a Show Cause Notice under Section 20 (1) of the RTI Act, 2005, was issued to him to be present in the court on 18.02.2020 along with his written submission. The PIO did not bother to attend the court in person or to depute any other official, on his behalf.

4. It also transpires that the sought information has also not been supplied and the compensation amount of Rs.4000/- has not been paid to the Appellant till date. It is clear that he does not have any respect for the statutory institution. Therefore, the Commission cannot take it lying down. The matter has to be taken to a logical end. While exercising its authority under Section 18(3)(a) of the RTI Act, 2005, a bailable warrant is issued against Shri Parvesh Singh, BDPO-cum-PIO with the direction to the Senior Superintendent of Police, Fazilka, to serve it on him to appear along with entire relevant record before the Commission on 01.04.2020 at 11.30 AM, so that the requisite information can be arranged to be furnished to the information seeker and appropriate action is taken on the show cause notice issued to him.

5. In view of the above, I order to enhance the compensation amount Rs.4000/- to Rs.5000/- awarded to the Appellant Shri Hardeep Singh. The Respondent-PIO is directed to make the payment of compensation amount of Rs.5000/- (Rupees Five Thousand only) through cheque / demand draft issued from the Funds of the Public Authority within 15 days and copy of the same cheque/demand draft be sent to the Commission for record.

6. Adjourned and to come up on **01.04.2020 at 11.30AM**. Copies of order be sent to the parties.
