ORDER

The RTI application is dated 13.07.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) dated NIL and second appeal was filed in the Commission on 01.01.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Notice of hearing was issued to the parties for 18.02.2020 in the Commission.
3. The Appellant states that the complete information has not been provided to him so far.
4. The Respondent states that the information pertaining to point no.1 and 2 is not available in their official record. Further, the appellant has not paid the documentation fee
