2. The respondent-Public Information Officer-cum-CDPO handed over the bank draft bearing No. 486411 dated 17.3.2021 amounting to Rs.3000/- to the representative of the appellant. She also handed over the copy of an affidavit along with the copy of relevant pages of the register related to the sought information and states that no copy of PLA forms is available in the office except No. 151700, 151701, 151699, copy of which has already been supplied to the appellant. In addition, she also states that during the year 2009-10 Chairman Block Samiti, fazilka was the passing authority of pensions and the record regarding the remaining forms may be available in the office of Chairman, Block Samiti, Fazilka.

3. After taking the bank draft, copy of an affidavit and the copy of register, the representative of the appellant showed his satisfaction.

4. Keeping in view the submissions made by the respondent-Public Information Officer-cum-CDPO, the Public Information Officer o/o the Block Development and Panchayats Officer, Fazilka, who is the controlling office of the Chairman Block Samiti, Fazilka, is impleaded as necessary party in this case. He is also directed to file the reply/supply of information as has been sought by the appellant before the next date of hearing. A copy of the RTI application is also being **sent** along with this order.
