After examining the documents placed on record, it is found that the respondent PIO has sent a point-wise reply (for remaining information) through a letter dated Nil, signed by Chairman, Gram Panchayat Water Supply and Sanitation Committee, Gige Majra, which has been received in the Commission vide Diary No. 4914 dated 09.03.2022. It is taken on record and a copy of the same is also handed over to the appellant during the proceeding of the instant appeal-case.

As the respondent has sent the above-mentioned reply to the Commission not to the appellant, hence, directions are hereby given to PIO office of Chairman, Gram Panchayat Water Supply and Sanitation Committee, Gige Majra to send the above-said reply under his signature to the appellant through registered post with a copy to the Commission.

An opportunity is also given to the appellant to confirm whether he received the information/reply or not and also to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned and also send a copy of the same to the Commission.
