1. Kindly provide me the certified point wise information regarding towing vehicles by police/traffic police the government and non-government vehicles running in Ludhiana city and villages.
2. Kindly provide me the certified copy of list of police and traffic police under towing vehicles running in the Ludhiana city and rural areas for towing vehicles for wrong parking and no parking.
3. Kindly provide me the certified copies of the agreements provided to the department by the owners of the vehicles which have been towing.
4. Kindly provide me the certified copies of the insurance, pollution and R.C of the same towing vehicles.
5. Kindly provide me the certified copies of the receipt of high security number plates of towing vehicles.
6. Kindly provide me the certified copies of the driving licence of the drivers of same vehicles.
7. Kindly provide me the certified copies of the police verification of the driver and conductor private PCC.
