The appellant, Sh. Janak Raj, who appeared in person in today's hearing, states that incomplete information has been given to him by the respondent PIO.

Nevertheless, the appellant is advised to visit the office of the respondent PIO to inspect the relevant official record on 24.05.2022 at 11:30 A. M. to identify the remaining information.

The respondent PIO concerned is directed to facilitate the appellant to inspect the relevant official record during his visit to the office on 24.05.2022 and supply the remaining information (except information at point no. 01 of RTI request) to the appellant with a copy to the Commission.

An opportunity is also given to the appellant to confirm whether he has received the information, which would be supplied to him by the respondent PIO after inspection, or not.

Both the parties mutually agreed to it during the hearing today.

The date and time of visit of the appellant and inspection of the relevant official record in the office of the respondent has been announced to the parties during the proceedings of the instant appeal-case.

The case is adjourned to 27th October, 2022 (Wednesday) at 11:00 A. M. for hearing
