The Commission observes that there has been an enormous delay of one year in providing the information. The Commission has taken a serious view of this and hereby directs the PIO to **show cause why penalty be not imposed on him under Section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time.** He/she should file an affidavit in this regard. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The PIO is again directed to provide the information within 10 days.

ORDER: This order should be read in continuation to the earlier order.

On the last date of hearing on **21.01.2020**, The respondent pleaded that the complete information has been provided to the appellant and the appellant has received the same.

In the hearing on 16.12.2019, it was observed that the PIO had used section 8(e)(j) without applying his mind which appeared to be an attempt to stonewall the information with a malafide intention, a show cause notice was issued.

The respondent submitted a reply to the show cause notice stating that they were not adequately trained to handle the RTI applications and this was the result of incompetence. The plea was accepted and the show cause was dropped.

However, the Commission was of the view that the appellant had to suffer undue harassment while seeking information which was denied to him due to poor application of mind of the PIO. The PIO was directed to pay an amount of **Rs.5000/-** via demand draft drawn through Govt. Treasury as compensation to the appellant for the loss and detriment suffered by him of having to file the appeals and not getting information in time. The PIO was directed to duly inform the Commission of the compliance of the order and send proof of having compensated the appellant within 15 days.

ORDER: Facts of the case-

- That Sh.K.N.Sodhi through RTI application dated 21.12.2018 sought information regarding land allotted under Industrial Land Policy to different institutios in sector 70 alongwith Memorandum of Articles, approval of land, site plan etc from the office of GMADA Mohali.

Appeal Case No. 1625 of 2019

- That the appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 19.01.2019 which took no decision on the appeal. After filing first appeal, the PIO sent reply to the appellant stating that the information sought is not specific and the appellant was asked to inspect the record and get the relevant information.
- That on not being satisfied with the reply of the PIO, the appellant filed second appeal in the Commission.
- That the case came up for hearing on 14.11.2019. Sh.Gulshan Kumar, PIO appeared and pleaded that the appellant has already inspected some of the files and the appellant can inspect the other files. The representative appeared on behalf of the appellant agreed for the same.
- That on the next date of hearing on 27.01.2020, the appellant informed that after inspection of record, the appellant had flag marked the information required by him but the PIO had not supplied the information
- That since the PIO was absent and the respondent appeared on behalf of the PIO could not reply on the submission of the appellant, the PIO was issued a show cause notice under section 20 of the RTI Act. The PIO was directed to file reply on an affidavit. The PIO was also directed to provide the information to the appellant within 10 days.
- That on the last date of hearing which was held on **25.02.2020**, the PIO was again absent nor had sent reply to the show cause notice. The PIO was given one last opportunity to file reply to the show cause notice and provide the information to the appellant.
- That the case has come up for hearing today through video conference facility available in the office of Deputy Commissioner, Mohali. The appellant informed that the PIO has not provided the information

- That at the last hearing, the PIO was given one last opportunity to provide the information and reply to the show cause notice. The respondent is absent nor has sent any reply to the show cause notice.

Since the responsibility to ensure the timely transmission of the information to the appellant lies on the PIO and the PIO has failed to provide the information within the time prescribed under the RTI Act, such an enormous delay in providing the information cannot be condoned. The PIO has also failed to comply the order of the Commission. The PIO-GMADA is hereby held guilty for not providing the information on time as prescribed under section 7, which is within 30 days of the receipt of the request, and for repeated and willful defiance of the Punjab State Information Commission's orders.

A penalty of **Rs.10,000/-** is hereby imposed upon the PIO-GMADA, Mohali which be deposited in the Govt. Treasury. The PIO, GMADA is directed to duly inform the Commission of the compliance of the orders by producing a copy of the challan justifying the deposition of the penalty in the Govt Treasury.

Further, the Commission is of the view that since the appellant has had to suffer undue inconvenience to get the information, it is a fit case for awarding compensation to the appellant u/s 19(8)(b) of the RTI Act.

The PIO-GMADA Mohali is directed to pay an amount of **Rs.3000/-** via demand draft drawn through Govt. Treasury as compensation to the appellant for the loss and detriment suffered by him of having to file the appeals and not getting information in time. The PIO is directed to duly inform the Commission of the compliance of the order and submit proof of having compensated the appellant. The PIO is again directed to provide the information within 10 days.

The case is adjourned. To come up for further hearing on **11.08.2020 at 11.00 AM through** video conference facility available in the office of Deputy Commissioner, Mohali.

ORDER:

The appellant through RTI application dated 12.06.2019 has sought information regarding allotment of religious sites to religious bodies – Dera Radha Swami Satsang Beas since inception of Mohali and other information concerning the office of GMADA Mohali. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 25.07.2019 which took no decision on the appeal. The earlier order stands. The PIO is directed to comply with the earlier order of the Commission and provide the information to the appellant.
