This order may be read with reference to the previous order dated: 09.07.2019.

- 2. The appellant states that no information has been provided to him by the Respondent PIO till date.
- 3. Sh. Harpreet Singh, Leave Reserve Clerk/Bill Clerk appears on behalf of the Respondent PIO and states that and states that the Appellant has sought the third party information, the same cannot be supplied to him. He further states that the First Appellate Authority called the Appellant for personal hearing but he did not turn up.
- 4. After examining the case file, it is ascertained that information sought by the Appellant is related with his own Son and not with the third party. Therefore, the Respondent PIO is directed to appear personally and provide the complete information as per his RTI application dated: 26.06.2019, within a week to the Appellant, failing which strict action will be initiated against him as per provisions of the RTI Act, 2005.
- 5. The case is adjourned to **25.07.2019 at 11:30 AM.** Copies of the order be sent to the parties.
