ORDER (Third hearing):

1. This order may be read with the reference of previous order 13.04.2022 vide which the respondent authority was absent.
2. Appellant, Dr. Jatinder Pal Singh no information has been received so far from the respondent.
3. Respondent, Sh. Jasbir Singh submitted the unconditional apologies for the delay in dealing this RTI application and assured the Commission that he will furnish a reply/information within 30 days.
4. In view of above, Commission notes that the PIO has not taken full and complete action as per the directions of the first appellate authority thereby causing detriment to the interests of the appellant. Accordingly Commission directs that the compensation of Rs. **5,000/-** be paid to the appellant by the public authority in terms of section 19(8)(b) of the Act. The compensation amount of **RS.5,000/-** must be paid by the concerned PIO through cheque and demand draft in favour of appellant Dr. Jatinder Pal Singh from the account of public authority and not from individual account.
5. After hearing both the parties and as per the assurance given by the respondent Sh. Jasbir Singh, the Commission offers the respondent authority another opportunity to furnish the information/reply requested by the appellant and to report its compliance to Commission, before the next date of hearing. Failing to this adverse view will be taken under RTI Act 2005.
