1. Please verify the birth certificate of Lovejot Singh s/o Satnam Singh S/o Ajit Singh, mother's name is Sarabjeet Kaur village Balya Manjhpur, Jandiayala Guru, Amritsar. The said person allege that his date of birth is 15.01.1999, by Matriculation Certificate.
2. Pleas provide me copy of information received from village panchayat concerning birth of said person along with copy of birth certificate of Lovejot Singh s/o Satnam Singh S/o Ajit Singh detailed above.

3. Please verify the birth certificate of Lovejot Singh s/o Satnam Singh date of birth 5.01.1999, R/o Village Balya Manjhpur, Jandiayala Guru, Amritsar detailed above.
4. Please provide me document to concerning issuance of above detailed birth certificate by verify signature of the Lamberdar Balkar Singh of village Baliya Manjhpur, (Amritsar). And documents concerning to his power to do so.
5. Please provide the detailed information of chokidar Sh. Ajit Singh of the village Baliya Manjhpur, Amritsar. His date of appointment and period of service.

Today at the time of hearing I have heard both the parties, the appellant and as well as the respondent. The respondent stated that the reply/information which was sought by the appellant was sent to him through letter no.320-21 dated 14.05.2020 and it is replied that no entry of birth regarding Lovejot Singh s/o Satnam Singh S/o Ajit Singh, mother's name is Sarabjeet Kaur village Balya Manjhpur, Jandiayala Guru, Amritsar is found in the records of the public authority for the year 1999, so verification cannot be done.

The information regarding point no.1, 2 and 3 is not part of the records of the public authority as no entry is found in the records of the public authority as alleged by the appellant, so certificate cannot be verified.

The information sought by the appellant through point nos.4 and 5 of the RTI application is not related with the public authority, hence cannot be replied as is not part of the records of the public authority.

Similarly letter no.239 dated 26.06.2020 was sent by Additional District Registrar, Birth & Death, Amritsar to the PIO, O/o Civil Surgeon, Amritsar and it is mentioned in the letter that the birth entry of Lovejot Singh, S/o Satnam Singh S/o Ajit Singh Mother's name Sarabjeet Kaur D.O.B. 15.01.1999 regarding Village Balya Manjhpur has not been found in the records of the concerned village.

Another letter no.279 dated 15.07.2020 was written by Additional District Registrar, Birth & Death, Amritsar to the PIO, O/o Civil Surgeon, Amritsar and it is written in the letter that no birth entry regarding Lovejot Singh S/o Satnam Singh S/o Ajit Singh Mother's name Sarabjeet Kaur is found in the records for the period 01.01.1999 to 31.12.1999.

Hence as the information sought by the appellant to verify the birth certificate of Lovejot Singh D.O.B. 15.01.1999 as alleged by him is not found in the records of the public authority and the SPIO O/o Registrar, Birth and deaths, Amritsar informed the appellant through the above said letters. It is therefore the present appeal case is **disposed of and closed**.
