Shri Rajinder Singh Sekhon, complainant/applicant filed RTI application dated 06.10.2020 and sought some information from the SPIO, O/o Tehsildar, Goindwal Sahib, Tarn Taran. When no information was provided to him by the SPIO, then he filed complaint against the SPIO before the Punjab State Information Commission on 15.04.2021. The case was registered and allocated to the Bench. The Notice of hearing was issued to both the parties for today through **CISCO Webex Meetings Software**.

The appellant is absent today, whereas the respondent is present on behalf of the SPIO.

The respondent stated that the applicant has filed RTI application on 06.10.2020 and the information has been sent to him vide letter no. 16 dated 26.04.2021 through registered post, but the applicant was not satisfied with the information relating to point no. 2 of the RTI application.

The respondent further stated that the reply regarding point no. 2 of the RTI application has been sent to the applicant vide letter dated 22.07.2021 that the information sought by the applicant is a third party information.

As per the reply of the respondent the information regarding point no.2 of the RTI application cannot be provided to the applicant as the applicant has no relation or concern with the information sought, so the information cannot be provided as it is within the fiduciary relationship as defined U/s 8(1)(e) of the RTI Act, 2005. Moreover, the applicant has not sought any specific information regarding any specific Vasika. So, the complaint filed by the complainant is hereby **disposed of and closed**.
