The Appellant states that irrelevant information has been provided to him.

The PIO further filed the reply of show cause notice issued to him in the shape of affidavit in the Commission mentioning the reason of delay and requests for exemption from penal action or fine. Keeping in view all the facts mentioned in the reply the show cause notice is hereby is dropped.

In the aforementioned facts, the Bench observes that sufficient reply/information has already been supplied to the appellant and no further action is required in this case, hence the Appeal Case is **disposed of and closed.** I have taken a lenient view and not imposing any penalty, but the PIO is warned more careful in future while dealing with the matters pertaining to the RTI Act, 2005 and act swiftly. Copies of the order be sent to the parties.
