I have gone through the Order dated 05.09.2018. The information was provided to the appellant and he was satisfied except the information regarding Para Nos. 1, 3 and 9 of the RTI application. A direction was issued to the PIO-cum-BDPO, Malout that complete information be provided to the appellant regarding Para Nos. 1, 3 and 9 of the RTI application within 15 days.
