It is submitted in the affidavit that the SPIO has tried her best to trace out the record related with the information sought by the appellant, but the same could not be traced, so the information sought by the appellant cannot be provided.

As the SPIO has submitted in the affidavit that the information cannot be traced out in the office of the public authority, so she is unable to provide it to the appellant. So, I think that inspite of the best efforts made by the SPIO, the information sought by the appellant could not be traced and she is unable to provide it. Hence, the present appeal case is disposed of and closed with the observation that the copy of the affidavit be sent to the appellant along with the order of the Commission.
