## ORDER

This order may be read with reference to the previous order dated 23.9.2021.

2. The appellant has sought the following information:-

The respondent-Public Information Officer states that the bank draft amounting to Rs.10,000/- (Rupees Ten thousand only) has already prepared to be paid as compensation to the appellant and will be sent to him through registered post with a copy to the Commission. He also states that the information as per official record has already been supplied to the appellant and nothing more is available in the official record of the BDPO/Panchayat Secretary which could be supplied to the appellant. He also tenders unconditional apology for the delay occurred in this case and requested to withdraw the show cause notice issued to him. He has already submitted the written reply in this regard, which is taken on record.

4. Keeping in view the assurance given by the appellant that the draft has already been prepared and the same will be sent to the appellant through registered post and the

submissions that nothing more is available on record which could be supplied to the appellant, therefore, the respondent-Public Information Officer is directed to send the bank draft to be paid as compensation to the appellant amounting to Rs.10,000 through registered post within two weeks from the issue of this order with a copy to the Commission. With these directions, the case is disposed of and closed. However the liberty is granted to the appellant to approach the commission within four weeks in case he does not receive the bank draft amounting to Rs.10,000/- as mentioned herein.
