In today's hearing, Sh. Vijay Kumar states that a Court case has been going on in the Hon'ble Court, that's why they are not supplying the information to the Appellant under the Section 8 (h) of the RTI Act. He further states that the Chief Agriculture Officer is on leave due to family medical emergency. In relating to same he further mentions about an email dated 17.11.2020 which has been sent to the Commission signed by Sh. Viney Kumar, Public Information Officer –cum- Chief Agriculture Officer, Hoshiarpur.

On this, the Appellant, Sh. Majhel Singh states that no information has been supplied to him and no case is going on, in the Hon'ble Court.

After going through the case file and discussing with both the parties, it is observed that Superintendent, Sh. Vijay Kumar is unable to clear the facts of this case and when he is asked to explain why the information cannot be supplied to the Appellant under Section 8 (h) to which he was unable to answer anything.

Commission takes a serious view of the casual approach of the Respondent/ PIO. An opportunity is given to the concerned PIO and he is directed to explain the facts in writing that why the information cannot be supplied to the Appellant under Section 8 (h) of the RTI Act, 2005 **else** PIO is further directed to supply the information to the Appellant **by registered post or through email along with a copy to the Commission** relating to his RTI Application by the next date of hearing positively failing which an action could be taken against the concerned PIO on the next date of hearing.

The Respondent/PIO concerned is also directed to submit copy of postal receipt or submits a copy of an email (to the Commission), through which information would be sent to



the Appellant or the letter would have been sent to the Appellant vide which the facts would have been cleared by the PIO for not supplying the information to the Appellant under Section 8 (h), would be sent to the Commission, by the next date of hearing positively.

The Appellant is directed to go through the requisite information or letter, once he receives the same from the Respondent/PIO and point out deficiencies in written, **if any**, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

This case was last heard on 07.09.2020 vide which last opportunity was given to the Appellant and he was directed to visit the office of the Respondent on 09.09.2020 at 11.00 A.M. to hand over the letter (through which the deficiencies has been pointed out by the Appellant) to the Respondent / PIO and send a copy to the Commission.

In today's hearing, the representative of the Appellant, Sh. Amarjit Singh states that he had visited at concerned office on 09.09.2020 and had gone through 47 files and also written to the concerned office about the deficiencies in which they had pointed out they need Name of Work, Addresses, MB Books, Bill, Amount and the name of the agency to whom the work had been assigned (i.e. in relating to those 47 files.)

On this, the S.D.O., Sh. Harjit Singh states that the deficiencies which has been pointed out the Appellant is not clear as he should be more specific and he could collect the information by hand after visiting at their office again.

While discussing it has been found that Sh. Amarjit Singh who is present today on behalf of the Appellant; is present without any authority letter and also the Appellant, himself did not visit for inspection at the concerned office on 09.09.2020, which is unacceptable.

In view of above, the Appellant is directed to visit the concerned office himself i.e. no authorized person will visit on inspection, on behalf of the Appellant. The Appellant, Sh. Sarabjeet Singh (himself) will visit on **09.12.2020 at 11.00 A.M.** for collecting the requisite information after identifying the records as per his RTI Application. **The concerned PIO, other concerned officials and Sh. Harjit Singh, S.D.O. are directed to be present there on the said date and time to facilitate the Appellant for inspection of records and to supply the record.**



If the Appellant doesn't visit for inspection today then it will be presumed that the Appellant is satisfied and he doesn't require the information anymore and the case will be decided on merits.

**PIO is directed to supply the remaining information (after inspection) to the Appellant by hand at the time of his visit.**

The Appellant is also directed after inspecting, if he observes that as per RTI Application if any information is remaining or he is not satisfied with the same, then he could write that down and supply the letter of deficiencies by hand to the PIO or to the concerned officials at the time of inspection along with a copy to the Commission through email failing which it will be presumed that he does not require the information anymore and the case will be decided on merits.

This case is adjourned to **06.01.2021 at 11:00 A.M.**' and both the parties are directed to be present on the next date of hearing i.e. **06.01.2021** which is going to be heard through **Video Conference Software/ Application Cisco Webex Meetings. Meeting Id Number : 918782948.**
