*(To be read in continuity with earlier order on 13.11.19, 15.1.2020, 4.3.2020, and 2.6.2020, 5.8.2020, and 30.9.2020)*

1. The complainant, Baljeet Kaur, filed this RTI application dated **6.7.19** and sought **information pertaining to details of her land acquired by the government and the compensation paid thereon**, from the PIO o/o Sub Divisional Magistrate, Fatehgarh Sahib. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **16.9.19**. The case was last heard on **30.9.2020**.

2. Both the parties are present through Video Conference at DC office at Mohali. The Complainant stated that she has received the information as directed by this Commission at the last hearing. However, she contended that the information furnished is incomplete as there is no clarity about what portion of her 400 square yards plot situated along the highway has been acquired by the NHAI.

3. The respondent PIO, represented by Jaspal Singh, Reader, accompanied by the concerned Patwari clarified that it is not feasible to give accurate account of what portion of her plot has been acquired until the mutation (*intkal*) is carried out in favour of the NHAI. The respondents however, agreed to provide an assessment of the share (*hissedari*) as per which the aforesaid plot was acquired by the NHAI.

4. In addition to the above, the respondent PIO is directed to submit an affidavit, citing each of the queries in the RTI application and clearly stating, what information/documents have been provided to the complainant and why it is not feasible to provide information regarding the portion of Complainant's 400 square yards plot acquired by the NHAI. The original Affidavit is to be handed over/sent by Registered post to the Complainant. A copy of the same along with copy of postal receipt is to be sent to this Commission.

Any failure to comply could invite penal action as per RTI Act 2005.
