- 1. The RTI application is dated **29.1.2020** vide which the appellant has sought information <u>regarding rules / policies of GMADA</u>, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) On **9.3.2020** and second appeal was filed in the Commission on **10.6.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.9.2020**.
- 2. Both the parties are absent for the second time in succession. However, as per letter dated 6.10.2020 to this Commission from the superintendent (Policy Branch) GMADA, it has been stated that the information was sent to the appellant on 27.2.2020, which, was well within the stipulated 30-day period from the receipt of the RTI application on 29.1.2020.
- 3. The appellant failed to apprise the Commission of the PIO's reply when he filed the second appeal to the Commission on 10.6.2020. Notably, there has been no communication from the appellant, either to the respondent PIO or this Commission since Notice was issued for this appeal case. Under the circumstances this Commission is compelled to conclude that the appellant is satisfied with the information furnished and no longer wishes to pursue this case.
- 4. There is no further cause for action and this appeal case is herewith **CLOSED**.

- 1. The RTI application is dated **8.7.19** vide which the appellant has sought <u>information</u> <u>pertaining to authorized and unauthorized colonies etc.</u> as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **9.8.19** and second appeal was filed in the Commission on **24.9.19** under Section 19 of the Right to Information Act, 2005. The case was last heard on **30.9.2020**.
- 2. Both the parties are absent without intimation. At the last hearing on 30.9.2020, the respondent PIO was directed to furnish a list of PIO's, APIO's and any other officials dealing with the RTI Act in M.C., Zirakpur along with their name, designation and telephone numbers as on date. However, in a letter received in this Commission on 6.10.2020, the EO-cum-PIO MC Zirakpur, has stated that no other officials have been specifically designated to deal with RTI applications, and that the RTI requests are sent to different branches to collect the requested information. This reply address the remaining queries listed in the appellant's RTI application.
