Shri Avtar Singh, complainant/applicant filed RTI application dated 18.07.2019 and sought some information from the SPIO, O/o SSP (Rural), Ludhiana.

Advocate Nitin Mattu is present on behalf of the complainant-applicant and SI Arshpreet Kaur Grewal, SHO, Police Station, City Jagraon is also present.

The counsel of the applicant stated that the sought for information has not been provided to the applicant by the SPIO till date.

SI Arshpreet Kaur Grewal, SHO, Police Station, City Jagraon stated that the record regarding the information sought by the applicant is not traceable in the office of the Police Station, City Jagraon. She further stated that a departmental inquiry is being conducted regarding this by the DSP, Jagraon.

So, the SPIO is directed that in case the sought for information is not traceable or available in the record of the public authority, then the SPIO should submit a duly attested affidavit in two sets by submitting that the information sought by the applicant is not traceable or available in the record of the public authority and send one affidavit to the Commission and other to the applicant within a week. In case of non compliance of the Order of the Commission, a show cause notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO on the next date of hearing.
