- iii) For part information at point no. 14 demanded by the appellant through RTI request, Public Information Officer office of B. D. P. O., Ghall Khurd was impleaded as necessary party in this case with the directions to bring certified copies of the required information at point no. 14 in the Commission.
- 4. After examining the documents placed on record, it is found that the notice of hearing issued by the Commission vide letter no. 48352 dated 31.10.2022 in the name of the Public Information Officer office of Panchayat Secretary, Gram Panchayat, Village Sherkhan Wala, Block Ghall Khurd, Distt. Ferozepur is received back in the office of the Commission as 'undelivered' through Diary No. 25846 dated 10.11.2022. It is taken on record.
- 5. Today neither the appellant nor the respondent is present today. Last opportunity is given to J.E., o/o BDPO, Ghall Khurd to appear before the Commission alongwith information pertaining to point no. 14.
- 6. To come up on **19.12.2022 at 12.00 PM** for further proceedings in the Commission. Copy of the order be sent to the parties.
