ORDER

This order may be read with reference to the previous order dated 3.3.2021 vide which the case was adjourned for 8.4.2021 but the case could not be heard due to administrative reasons the case was further adjourned for today i.e. 18.5.2021.

2. The appellant states that he is not satisfied with the reply of the respondents and requested that the directions may be issued to the respondent-Public Information Officer to supply the complete information.

3. None is present on behalf of the respondents. Also no reply has been received from the office of the Block Development and Panchayats Officer, Fazilka regarding show cause notice issued on 3.12.2020. The perusal of the file shows that in this case, application for information was filed on 10.06.2020 but after a lapse of more than eleven months, incomplete information has been supplied to the appellant. It is, thus apparent from the response of the respondent-Public Information Officer that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.

4. **I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 5000/- (Rupees Five thousand only) by way of compensation to the Appellant. This amount shall be payable by the office of the Block Development and Panchayats Officer, Fazilka from the State Exchequer before the next date of hearing.**

5. Also the respondent-Public Information Officer is directed to file the specific reply/supply the information in this case before the next date of hearing failing which the penalty provisions will also be invoked.

3. The appellant showed his satisfaction with the reply given by the Block Development and Panchayats Officer sent to him through whatsapp during the course of hearing. He has also requested for a hard copy of the same. He also states that he has no objection, if the case is closed. Therefore, a copy **of the letter sent by the Block Development and Panchayats Officer is being sent along with the order.** According to the submissions made by the appellant no further action is required to be taken to supply the information in this case and the case is closed. However, no reply has been received from Shri Harkeet Singh Block Development and Panchayat Officer regarding show cause notice issued to him. One last opportunity is granted to submit his reply regarding show cause notice issued to him failing which an ex-parte decision will be taken on the next date of hearing.

This order may be read with reference to the previous order dated 25.2.2021 vide which the case was adjourned for 8.4.2021 but the case could not be heard on that day so the case was further adjourned for hearing today i.e. 18.5.2021.

2. The appellant sought the information pertaining to interlock tiles installed at Phirni (ਫਿਰਨੀ) of Village Mianwal Molvia (ਮੀਆਵਾਲ ਮੌਲਵੀਆ) from the residence of Sh. Charanjit Singh s/o Sh. Udham Singh to Sh. Ram Lubhaya s/o Kartar Chand).

3. The appellant states that he has received the complete information except the copies of bills. Due to on-going corona pandemic one last opportunity is granted to the Panchayat Secretary to file the reply regarding show cause notice issued to him failing which ex-parte decision will be taken on the next date of hearing.
