ORDER:

1. The RTI application is dated **11.12.2020** vide which the appellant has sought information **regarding a complaint bearing Diary No. 3883-PS-R dated 7.12.2020**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **11.1.2021** and second appeal was filed in the Commission on **10.3.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **18.8.2021**.

2. Both parties are present via Video Conference Facility from Ludhiana. The respondent PIO, represented by Om Parkash, Inspector, stated that the complaint cited in the RTI application was transferred for enquiry to the Superintendent, Local Government at Mohali. In a submission made to this Commission vide Letter No. 527/C dated 17.8.2021, the respondent has also cited Appeal Case no. 10044 of 2010, wherein the Supreme Court has clearly laid down the law regarding personal and third party information.

3. This Commission is satisfied that the respondent has duly informed the appellant regarding the status of the complaint (cited in the RTI application). As regards any detail of any investigation arising out of the complaint, against an officer of the Municipal Corporation, Ludhiana, The respondent PIO has rightly invoked the aforesaid Supreme Court Order to deny the information.

First appeal was filed with the First Appellate Authority (FAA) on **8.2.2021** and second appeal was filed in the Commission on **30.3.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **18.8.2021**.

2. Both parties are present via Video Conference Facility from Ludhiana. The respondent PIO-cum-ATP, Satish Malhotra accompanied by Kashish Garg, APIO-cum-Building Inspector, have vide Letter No. 662/DRG-C/D/PIO dated 8.6.2021 informed the Commission that a reply/information was sent to the appellant vide Letter No. 483/DR4/PIO dated: 23.2.2021 and that no deficiency was pointed out by him. It is again noted that the appellant has failed to attend the hearing before the Joint Commissioner-cum-First Appellate Authority on 26.2.2021 and instead went on file the Second Appeal. The appellant has not been able to provide any satisfactory response as to why he does not attend the hearings of First Appellate Authority.

3. Ordinarily this Commission, would have reverted back to this case to FAA's, however, in this instance, the appellant, Gurmej Lal, stated that he has received the information in this case and does not wish to pursue this case further.
