This is the complaint case, therefore, the attention of the complainant is drawn to the decision of the Hon'ble Supreme Court of India in its order dated 12.12.2011 in Civil Appeal Nos.10787-10788 of 2011 (arising out of SLP (C) No.32768-32769/2010), wherein it has been held that while entertaining a complaint case under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. As per the above decision of the Hon'ble Supreme Court of India, the Information Commission has power to receive and enquire into the complaint of any person who has been refused access to any information requested under this Act (Section 18(1)(b) or has been given incomplete, misleading or false information under the Act (Section 18(1)(e)} or has not been given a response to a request for information or access to information within time limits specified under the Act (Section 18(1)(c)}. In the complaint cases, it is to be seen whether the intention of the respondent-PIO is clear or not.

4. The complainant states that information sought by him is in public interest and should be supplied to him under the provisions of the RTI Act, 2005.

5. On the request of the complainant and keeping in view the public interest,
