the inference that the PIO, without any reasonable cause, has refused to furnish the information to the appellant and has malafidily denied him the same and thus, has rendered himself liable for punishment as provided under the RTI Act, 2005. Though he was given a number of opportunities to explain his position in connection with the **Show Cause Notice** issued to him under Section 20(1) of the Act *ibid*, he failed to come out with a satisfactory reply. In these circumstances, PIO O/o DEO(SE), Gurdaspur is held guilty of default on the above score. The facts of this case also prove beyond any doubt that the respondent PIO concerned does not deserve any kind of leniency. Hence, in exercise of the powers conferred by Section 20(1) of the RTI Act, 2005, a penalty to the tune of Rs. 10,000/- (Rupees Ten thousand only) is imposed upon PIO Sh. Surinder Pal, Superintendent O/o DEO(SE), Gurdaspur, to be deducted from his salary which is to be deposited in the State Treasury under the relevant head. An attested copy of the receipted challan is also directed to be presented before the Commission on the next date of hearing.
