Dr. Ravi Jindal, complainant/applicant filed RTI application dated 16.09.2020 and sought some information from the SPIO, O/o Civil Surgeon, Patiala. When no information was provided to him by the SPIO, then he filed complaint before the Punjab State Information Commission on 08.10.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today **through CISCO Webex Meetings Software.**

Both the parties are present today.

The SPIO stated that the sought for information comprising of 30 pages has been sent to the appellant vide letter no. 945 dated 01.12.2020.

The appellant stated that he has received the information and he is satisfied with the information regarding point nos. 1 to 4 of the RTI application, but no information has been provided to him by the SPIO regarding point nos. 5 to 9 of the RTI application and incomplete information has been provided regarding point no. 10 of the RTI application.

So, the SPIO is directed that he should file reply to the complaint filed by the complainant/applicant that why the complete information has not been provided to the complainant-applicant and send the same to the Commission as well as to the complainant/applicant within a week.
