Though, seemingly the sought for information has been supplied, yet, in order to satisfy the complainant, it directs the respondent to allow him an access to the record and provide the certified copies of the documents, if already not provided. The complainant shall restrict his demand up to 50 pages only."

"The case is being taken up today. The respondent is absent. The complainant suggests that despite having been approached the respondent has been avoiding to provide access to the information. A final opportunity is afforded to the respondent to ensure the compliance of the order as mentioned above. Failure to comply shall invoke the imposition of penalty as per provision of Section 20(1) of the Act."

The case has come up again today for hearing. Sh. Rajinder Kumar appearing on behalf of the respondent submits that the same information is being sought repeatedly by the complainant and his associate with a view to harass him only. Sh. Darshan Ram who has accompanied the complainant admits in the Court that he is in receipt of complete information but is not inclined to share it with the complainant who otherwise is his friend. This is intriguing. The Commission is inclined to accept the version of the respondent that the complainant is not genuinely interested to get the information. He seemingly has some oblique motives. The Commission as such is not inclined to intervene.



"The respondents are absent. On the last date of hearing the proxy for the respondent has assured this forum to provide the information to the complainant before the next date of hearing under intimation to the Commission.

None is present on behalf of respondents, nor has any written reply been filed. The Commission takes strong exception towards the callous and apathetic conduct of the respondent. Apparently, they have violated the provisions of Section 7 (1) of the Right to Information Act, 2005.

The BDPO is hereby issued a show cause notice under section 20(1) of the Right to Information Act as to why a penalty at the rate of Rs. 250/- per day, subject to a maximum of Rs. 25000/- be not imposed upon him for the delay in the supply of information and also to why a suitable compensation under Section 19(8)(b) of the RTI Act, 2005, be not awarded to the complainant for the loss and detriment suffered by him. He is also afforded an opportunity of personal hearing on the next date of hearing, before taking any action."

"The case has come up today for hearing. Sh. Hardeep Singh, Panchayat Secretary of Gram Panchayat, Satjot Nagar, submits that the street in question was not got constructed by the gram panchayat of the village of its location and the appellant has been informed by the BDPO accordingly. Simultaneously, he maintains that as the jurisdiction of the village has recently changed hands it is quite probable that the aforesaid construction might have been made by the gram panchayat of village Dhandla, its erstwhile local body. The Block Dev. & Panchayat Officer, Block – 1, PAU, Ludhiana, is hereby directed to clarify the position in the interest of the transparency to the complainant before the next date of hearing failing which it shall be presumed that they are willfully suppressing the information and the follow up action for such conduct shall be taken. Be it noted that a show cause notice stands already issued to him."

The case has again come up for hearing. Sh. Gurmail Singh, BDPO has come present. He has communicated in writing that his JE is on leave and as such he is not in position to give him the information. He says that the information shall be provided as and when JE joins.

The Commission is not inclined to accept the submission of the respondent. The original application was filed on 12.07.2018. Even after a lapse of about seven months the respondent is beating about the bush. The Commission senses malafide on the part of the respondent to suppress the information. A final opportunity is afforded to him to give the information complete in all respects strictly in accord with the application as is available in the office. Be it noted that he is already under show cause notice and the Commission has yet to take a call on the same.



Above three appeals have been entrusted to this bench on the request of Dr. Pawan Kumar Singla, Ld. SIC who has recused himself from these cases on alleged uncharitable comments.

As the appellant and the respondents are the same and the information emanates from the same source the subject appeals are clubbed together to be disposed by a single order.

The perusal of the applications suggest that the appellant is seeking outcome of a complaint made by him against some officials, the details of the officials appointed as invigilators during the conduct of Matriculation and Plus II examinations in the year 2017 and the remunerations paid ito them. The details of the medical/other leaves availed by the Principal of a school have also been sought. In another application he seeks to know the details of Principals having been reverted and posted on adhoc basis on the same assignment during the last couple of years.

The Commission finds that the appellant has been absent in most of the hearings with the former bench. A communication has been received from the appellant by this bench with the request to adjourn the case sine die as the appellant is gravely sick and is proceeding abroad for

treatment. The Commission wishes him a quick recovery.

However, the Commission observes that these are quasi-judical proceedings and are desirable to be disposed of expeditiously in a time-bound manner. The adjournment of cases for an interminable period shall defeat the public cause. The Commission has been given to understand that the appellant is a retired official of the department with a dubious past. He was dismissed from service to be reinstated at the time of superannuation.

The cursory perusal of his applications suggests that the appeals are intended to settle some personal scores with old colleagues and have not been filed in public interest. Having said so, the respondents say that they have brought along information comprising a couple of hundred of pages. The Commission has perused it and finds it apparently to be in order. The Commission is not inclined to accept his request to adjourn the case sine die and the same is rejected. The respondents are directed to send it by post at the given address under intimation to the Commission.

All the above appeals are **disposed.**
