2. The Respondents bring the remaining information as discussed on the previous date of hearing and same is handed over to the Appellant, during the hearing.
3. After going through the information, the Appellant acknowledges his satisfaction and wants to close the case.
4. Keeping in view of the above, no further action is required in this case. Hence the Appeal Case is **closed and disposed of**. Copies of the order be sent to the parties.
