ORDER:

2. Respondent, Sh. Gurmeet Singh pleaded that as the sought information is under investigation therefore it cannot be supplied. A written submission was made by him at the of hearing therein he mentioned that on the completion of the aforesaid enquiry he will supply the information. 3. Since the enquiry in the case is still pending and the Disciplinary proceedings are yet to be completed, hence divulging information to any one is likely to impede the disciplinary proceedings. Hence, the information sought for was denied under Section 8(1)(h) of the RTI Act.
4. In the light of the aforementioned settled position of law, this Commission is of the considered opinion that the contention of the respondent is found reasonable and there appears no reason to interfere with the same. The appellant is at liberty to obtain necessary information from the Respondent Authority at the appropriate stage, which as a matter of legal norm is anyway made available to the appellant.

With the above observations, the appeal is disposed of.
